

**THE DIERBERGS SUMMER “HOST YOUR OWN BACKYARD LUAU WITH DOLE” SWEEPSTAKES  
OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT ENHANCE YOUR CHANCES OF WINNING**

The Dierbergs “Summer Host Your Own Backyard Luau with DOLE” Sweepstakes (the “Sweepstakes”) is open only to legal residents of Illinois & Missouri who are 18 years of age or older at the time of entry. Employees, officers, directors and agents of Dole Packaged Foods, LLC (“Sponsor”), Dierbergs Markets, Inc.
